What is the project cost estimate?

<u>Answer:</u> A detailed Engineer's Opinion of Probable Cost <u>will not be provided</u> to the Bidders. However, the magnitude of the overall project cost for all schedules is anticipated to be \$7.5 - \$8 million.

Addendum Item 1.03

Please clarify the Note on sheet BP-5 of 24 of the Bid Proposal where it states: "NOTE: The line items listed in both Schedules B & C shall use the same unit price. If unbalanced between the schedules, the lower unit price shall govern.". Does this note include Schedule A as well?

<u>Answer:</u> For the same material line items which may be listed on both Schedules B and C shall be the same for both of those schedules and if shown differently, the lower of the unit price values will be used for the same material line item in both schedules. However, if a same material line item is listed on Schedule A and also shown on either, or both, Schedule B or Schedule C, the unit price in Schedule A <u>does not</u> need to be same unit price as shown in Schedule B or Schedule C.
